Rich Adams—Visual Services Advocate: locates assistive technology devices and has equipment available for demonstration and loan. Facilitates low vision support groups, Braille classes and home adaptations for people 55 years and older with visual impairment.

Deaf Services Advocate: assists people who are deaf and hard of hearing by providing advocacy, interpreter referral/training and assistive devices.

Dorothy Cox-Stowe—Home Services Advocate: assists consumers who want to recruit and manage their own Personal Assistants (P.A.) by providing a P.A. referral list and training for individuals interested in working as Personal Assistants.

Emily Dobson—Program Manager / Disability Awareness Team: assists consumers in the six-county service area on a variety of disability issues and heads the Disability Awareness Team which facilitates a variety of activities to foster the inclusion of people with disabilities.

Samantha McDermith—Independent Living Advocate: assists people with disabilities in identifying the appropriate community services needed to gain and/or maintain their independence.

Community Reintegration Advocate: assists individuals with disabilities living in nursing homes, as they move back into the community to live independently.

Family Advocate: provides support and services to students with disabilities and their parents. Services include transition, preparation for Individual Education Programs (IEPs) and support groups.

Doug Veach—Program Resource Advocate: fields incoming calls; assists staff and consumers by researching and maintaining a data base of community resources.

Betty Watkins—Rural Outreach Coordinator: supervises and assists in the implementation of the four core services in Moultrie, Shelby, Coles, Clark and Cumberland counties.
